WHEREAS, the Board of Trustees in their meeting dated 12/8/2011, the trustees of the trust decided in the meeting that Trust has to register under Sec. 12A of Income Tax Act. 1961. Under the Provision of Clause.3 of the Principal Trust, the Managing Trustee has got the powers to add or delete the existing clause.

In lieu of such powers vested in the Managing Trustee, the provisions of the trust deed are to be amended to bring the clauses of the Trust in consonance with the provisions of the Income tax Act, 1961, as the Trust is now applying for its registration with Income tax department u/s12A of the Income tax Act, 1961.

WHEREAS the Board of Trustees have resolved that the amendments of the Principal Trust shall be carried out before the Sub Registrar, duly represented by the Managing Trustee SRI. PUTTANNA

Now this Instrument witnesseth the amendments as under:
