PROTECTION OF CHILDREN FROM SEXUAL OFFENCES

MEASURES TAKEN BY SCHOOL TO PREVENT SEXUAL OFFENCES AGAINST STUDENTS

1. Teachers are made aware of POCSO ACT (PROTECTION OF CHILDREN FROM SEXUAL OFFENCES ACT 2012).
2. During the appointment teachers signed the ZERO TOLERANCE POLICY against sexual harassment and any form of abuse of children.
3. A POCSO Committee has been formed in the school to address the safety needs of students.
4. A discipline committee is formed to address disciplinary issues.
5. Teachers are assigned duties during lunch break, short break, entry and exits.
6. We have school counsellor whom children can approach for advice.
7. The entire school is under CCTV surveillance which includes class rooms, offices, activity rooms, playgrounds and corridors.
8. All support staff are ladies – housekeeping as well as bus transport attenders.
9. Police verification is done for all the support staff members.
10. Workshops are held on personal safety such as good touch and bad touch to ensure that awareness is created in students.
11. Only authorised guardians bearing the authorisation card are allowed to pick up the students from school or at the bus drop points.
12. Entry of visitors are strictly checked.
13. Child helpline number is put up on the notice board- 1098.

STANDARD OPERATIONAL PROCEDURE FOR CHILD ABUSE

1. In case of any such incident, the student will immediately inform the teacher/ Principal.
2. The Principal will verify the incident with the help of counsellor and respective teachers.
3. The Management and the parents will be informed. If required the police complaint will be lodged.
4. Accordingly, the necessary action will be taken after verifying the facts.
